The Importance of DWAB

We have established a Defence Women's Action Board that actively addresses and delivers solutions to the issues affecting women in Defence and Security. This distinction is important as we want to be as inclusive as possible and that includes women from the Armed Forces - serving and veterans, Industry, Academia, and Government as well as those in the Police, Fire, Blue Light, and Emergency Services. After the Atherton report, it was announced that there would be funding to address these issues, but it's currently not transparent where this is or how it will be allocated. We want to help that happen! Plus much more.

To deliver meaningful actions now, it will take private funding. Therefore, we have created DWAB as its own legal entity, moving it to be a not-for-profit, to be accessed by all. To reflect this we have changed the funding from Sponsorship to Membership to provide complete transparency of purpose and action, giving everyone a say on how and where we spend funding, and support those members directly as well.

In addition to the Corporate level memberships outlined here, we have also shaped the funding into 3 general streams that reflect the intentions of the suffrage movement worldwide:

Purple Fund - Loyalty & Dignity

Funding women to support their dignity by procuring their specialist clothing for work, energy bills, maternity wear and other hardship support.

Green Fund - Hope

Funding mentoring, education activities, course fees and maintenance grants whilst in education. Related funding for education enablers eg: IT equipment, software, or travel costs.

White Fund - Purity

Funding system and policy changes across organisations in support of equal rights. Working directly with organisations who already support these efforts. Funding legal support for women who experience discrimination.

CANCELLATION BY ORGANISER/FORCE MAJEURE
